3rd Health Programme (2014-2020)

On 26 February the European Parliament adopted the Commission proposal for the establishment of the third Health Programme 2014-2020. The next step in the procedure is the adoption of the programme by the Council. The Third Health Programme will run from 2014 to 2020, with a planned budget of 449 million EUR. It will support actions that complement, support and add value to the policies of the Member States to improve the health of EU citizens and reduce health inequalities by promoting health, encouraging innovation in health, increasing the sustainability of health systems and protecting Union citizens from serious cross-border health threats.

Horizon 2020 Launch Conference – presentations available for download

On **16 January 2014** the Horizon 2020 Launch Conference in Kyiv was jointly organised by BILAT-UKR*AINA, a project funded under the 7th Framework Programme by the European Commission (EC), and the Ukrainian State Agency on Science, Innovation and Informatization.

The Conference attracted more than 150 participants and informed the Ukrainian research and innovation community about Horizon 2020's mission, structure and participation opportunities. The EU-Ukrainian key priority areas identified by the Joint Science and Technology Cooperation Committee: Biotechnologies, Aeronautics, New Materials and Processing Technologies, and ICT were targeted by four parallel sessions and facilitated exchange of experiences and new ideas.

Afterwards BILAT-UKR*AINA organised a training event for Ukrainian NCPs focusing on new challenges and novel NCP services. BILAT-UKR*AINA will carry out a series of follow-up activities (i.e. webinars for Ukrainian researchers and project managers, up-to-date information about Horizon 2020 as well as thematic workshops targeting the thematic priorities) to further enhance joint EU-Ukrainian research projects and to promote Horizon 2020.

Call for Proposals for ERC Proof of Concept Grant. ERC-PoC-2014

The ERC Proof of Concept Grants aim to maximise the value of the excellent research that the ERC funds, by funding further work (i.e. activities which were not scheduled to be funded by the original ERC frontier research grant) to verify the innovation potential of ideas arising from ERC funded projects. Proof of Concept Grants is therefore on offer only to Principal Investigators whose proposals draw substantially on their ERC funded research.

There are 2 deadlines for submission to the ERC-2014-Proof of Concept: Intermediate deadline: 1 April 2014. **Final deadline: 1 October 2014.**

The EIT is launching the 2014 Call for Knowledge and Innovation Communities (KICs) proposals. Two new KICs will be selected focusing on innovation for healthy living and active ageing, and on raw materials – sustainable exploration, extraction processing, recycling and substitution.

“This is an exciting day in the EIT’s history that we have been working towards since the set-up of the first three KICs. The call offers a unique opportunity for leading universities, businesses and research centres to work with us and make innovation and entrepreneurship happen across Europe,” said Alexander von Gabain, Chairman of the EIT Governing Board.

“We look forward to co-operating with two more excellent and innovative partnerships that bring together entrepreneurially-minded people within European innovation ecosystems to tackle challenges facing our society and to create new opportunities for sustainable growth and jobs,” added José Manuel Leceta, EIT Director.

An Information Day will be held in Budapest on 14 March 2014. The application process is open until 10 September 2014. One KIC per theme will be designated on 9 December 2014, following an independent evaluation guided by specific selection criteria.

Call for bilateral proposals between Austria and Ukraine published!

Joint research teams consisting of Austrian and Ukrainian researchers can submit their joint proposals under the Intergovernmental Science and Technology Agreement between Austria and Ukraine until **2 June 2014**.

The broad thematic priorities targeted by this call include natural sciences, biotechnology research, ICT research, nanophysics and nanotechnology and high-energy physics. The projects should run from 1 January 2015 until 31 December 2016. Travel costs for short time mobility stays (maximum of 10 days) under the granted projects will be covered by the outgoing country, while costs for stays abroad will be covered by the incoming host country. For each project proposal a responsible lead applicant in Austria as well as in Ukraine has to be nominated. These lead applicants have to prepare joint proposals which have to be separately submitted in English or the national language(s) in Austria respectively in Ukraine. Austrian researchers have to submit the proposal online under <http://wtz.scholarships.at/login/login.aspx> with the following additional documents:

- application form (online)
- CV of all Austrian project participants (team)
- list of relevant publications of the last two years published by the Austrian team members
- project description incl. methodology (3 to 5 A4 pages)
- short description of the Ukrainian partner institution
- short description of the division of labour as regards all participants working in the joint project
